Client agrees to notify Dog Paws Pet Care of any concerns within 24 hours of any complaints.
4. Dog Paws Pet Care will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors.
5. Customer will be responsible for all medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. Customer agrees to indemnify and hold harmless Dog Paws Pet Care in the event of a claim by any person injured by the pet.

It is expressly understood Dog Paws Pet Care shall not be held responsible for any damage to client's property, or that of others, caused by client's pets during the period in which they are in her care. Client has advised Dog Paws Pet Care of all situations, which will relieve her of liability for damage.
